## THE DESIGN OF INFRASTRUCTURE FOR THE KWASHUSHU HOTSPRING AND NTUNJAMBILI MOUNTAIN TOURISM PROJECT SITES IN MAPHUMULO MUNICIPALITY, INCLUDING THE CONSTRUCTION OF ABLUTION FACILITIES

Enterprise iLembe hereby invites proposals from interested and experienced consulting firms to submit proposals for the design and the construction supervision of ablution facilities as well as provision of electrical and water supply for the KwaShushu Hotsprings & Ntunjambili Mountain tourism project sites located within the Maphumulo Municipality.
